

Art.1) TERMS AND CONDITIONS OF CANCELLATION - In case of cancellation of the reservation for the event "Venetian Reflections" no later than January 19, 2022, the customer will be entitled to a refund of 50% of the value of the ticket and extra services purchased; - In case of cancellation after January 19, 2022, the customer will not be entitled to any refund.

Art 2) RIGHT OF WITHDRAWAL - The Consumer acknowledges that since the Contract has as its object the supply of products and services related to leisure for which the supplier undertakes to supply them at a specific date or period of performance, the right of withdrawal does not apply.

Art 3)EVENT POSTPONED OR CANCELLED FOR REASONS NOT IMPUTABLE TO COVID-  
- The organisers reserve the right to cancel or suspend all or part of the event. In this case, the customer will have the right to receive a refund of the amount paid and the organisation will not be held responsible for any other action, request, loss and/or expense incurred by the customer.

Art3.) COVID-19 CLAUSE In the event of proven impossibility due exclusively to governmental provisions related to Covid-19 that prevent the customer from travelling and therefore taking part in the "Venetian Reflections" event, the organizer will issue a voucher for the amount paid to be reused for the purchase of tickets for a new edition of the event, with unlimited validity. The voucher may also be used for purchases and rentals at Nicolao Atelier. The voucher will be issued in the same way also in case the event cannot take place due to any restrictions or governmental regulations related to the covid -19.

Art.4) JURISDICTION Competent to decide any and all disputes arising from or in any way connected with the Contract shall be the Court of Venice. The online publication of these General Conditions of Contract and the confirmation of the purchase order provided by Costumi Atelier Nicolao SRL to the Customer are valid as "confirmation of the contract concluded on a durable medium" pursuant to art. 51, paragraph 7 of Legislative Decree no. 206/2005 ("Consumer Code").

Art.5) PRIVACY - BY PURCHASING A TICKET, EVERY GUEST AUTHORISES the company Costumi Atelier Nicolao srl and all those working on its behalf to film their image by television, photographic or cinematographic means with the right to use it for editorial, promotional or any other publication purposes;
